TaxServe is a windows-based property tax billing and collections application focused at providing the property tax assessor/collector with all the professional tools to quickly and easily manage the tasks of generating tax statements, collections of payments and all associated reporting requirements. It supports an unlimited number of jurisdictions.

Searching Accounts

Searching for account information is very simple, yet very powerful. A search can be as simple as entering an account number, or it can be as complex as looking for a partial account number, a partial name and partial address information.

Search information entered into the fields can be partial information, like 'per' in the name field and the search will look for account names beginning with the letters entered. The address information will search both the owner address and the service address.

Once the list is returned, it can be sorted by any of the fields listed in ascending or descending order just by clicking on the column title.

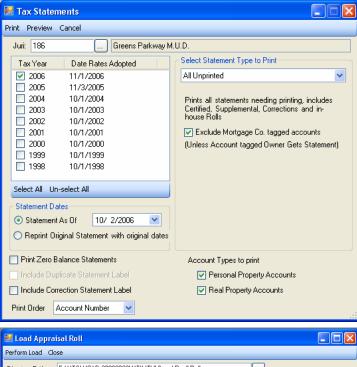
Double clicking on an account row will bring up a detailed account information window. You can open multiple accounts and view them all at the same time. This allows you to look for a different account while answering the phone, even while you were previously looking at another account.

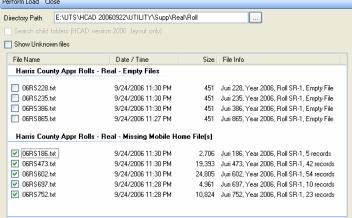
Account Information

TaxServe keeps all its information based on dates, allowing you to view the account information as is was as of any date. The account roll information is also kept in detail, meaning you never loose track of the certified roll information, even though a correction roll has updated the account. The delinquent fees are dynamically calculated using the As of Date field, allowing you to change the date and see the correct delinquent fees for the selected date.

Account information is shown within tabbed pages. The General tab shows general information like current owner address, service address and flags. The Tax Information tab shows the tax summary information along with the associated values and payment details for the selected tax year. The Name/Address History tab shows the account's owner's name and/or address historical changes. TaxServe keeps the name and address historical information based on a post date. The post date is the date the information becomes active, with the most current post date being the most current information.

Printing Statements

Printing of statements can be a tough chore. TaxServe provides a great number of options in printing statements.

TaxServe keeps track of an account's print status based on the rolls and name changes. When a new roll or name change is posted, the account is flagged as not printed. The print option 'All Unprinted' will print only those accounts that have not yet been printed. This allows you to post several rolls, Supplemental, Correction and Name Changes and then print all those that need to be printed in one pass.

Other printing options includes: printing Accounts with Balance Due, Delinquent Accounts Only, For a Tax Roll, For a Name Change Roll, For a Mortgage Company, For an Agent, For a Receipt Range, For a Specific Account, and Reprint All for the current roll.

Statement print jobs have a job start page listing the print options selected and a job ending page showing statistics.

Importing CAD Data

Getting CAD information into your system is a breeze with TaxServe. TaxServe has the logic to look into files and tell you which ones match supported import formats.

It is as easy as selecting a directory path of where the data files reside. TaxServe will look at all the files and present a list of the files that it can import along with the information about the files. It will group the files into the CAD grouping for easier recognition of the origin of the data files. All you have to do is check the box and click on Perform Load.

TaxServe has been updated to easily pull in multiple associated files when a CAD has separated information into multiple files. It especially supports HCAD's 2006 changed formats.

Jurisdiction Maintenance

TaxServe supports an unlimited number of taxing jurisdictions.

TaxServe is full of options for setting up multiple taxing jurisdictions. Each jurisdiction has its own settings for statement information. It supports setups of different legal fee rates and the dates that those fees begin, and they can be different between Personal and Real property.

TaxServe supports multiple taxing units, and each taxing unit can have multiple taxing rates, like MO and Debt, so that collections can be tracked by the taxing code.

TaxServe supports a large option of different exemption codes and methods for calculating the exemptions. Each Taxing Unit can have it's own set of valid exemptions.

Deposits

TaxServe provides an easy method of entering and tracking deposits. It supports any number of deposits per day.

TaxServe supports any number of bank accounts. Each Taxing Jurisdiction has it's own set of bank accounts.

The Deposits list has options to filter the list by a date range. This allows you to look for deposits within date ranges. There is a pull-down box that has quick select date range options like, This Month, Last Month, This Quarter, Last Quarter, etc. The list can also be sorted by any of the columns, also helping to fine a deposit by any of the fields.

Deposit Payments

TaxServe's main collection of payments is within a deposit. You create a deposit and then you add payments to the deposit. Deposit numbers are automatically generated across all bank accounts for tracking purposes.

It has balancing features to help with validating the deposit amounts.

Once all payments are entered into a deposit, you can print a deposit recap report that shows all the account payments, the breakdown of cash, check and credit card types, and the breakdown of the collection categories, taxes, rendition penalties, P&I, delinquent fees, etc.

Account Payments

Entering payments with TaxServe becomes an easy task with the high automation features it provides. The payment entry screen for an account shows all the tax years for an account, and allows payments for any of the years.

There are automaton buttons to quickly apply the payment in a multitude of ways. You can Apply To Taxes, Apply To Taxes w/Write-Off, Apply to Taxes w/Refund, Apply to Taxes w/Ratio, Apply to Escrow. These quickly fill in the correct distribution to the accounts.

You can also manually enter the amounts in the distribution fields. There are balancing totals to help with distributing the payment and checks to verify that all of the payment is apply correctly.
